In the event no applicant is approved as steward for the no cost conveyance, pursuant to Section 308 of the Act, the property will be offered for public sale. Historic covenants will be included in all deeds.

Any eligible entity with an interest in acquiring the Property for a use consistent with the purposes stated above should submit a letter of interest to the address listed below by October 29, 2008.

Eligible entities that submit a letter of interest will be sent an application by the U.S. Department of the Interior and given an opportunity to inspect the property. Building inspectors and/or contractors may accompany the applicant for the inspection. The completed application must be submitted to the U.S. Department of the Interior within 90 days of that inspection. The U.S. Department of the Interior will review applications and recommend a steward to receive the Property. The U.S. General Services Administration will complete the conveyance to the recipient.
